

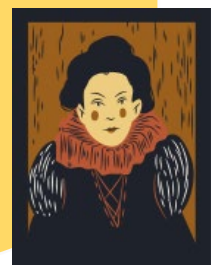

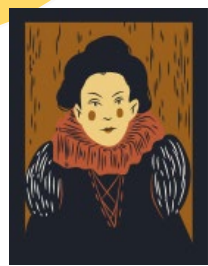


# INTERNATIONAL COMPETITION CURABILITY



## Goals

- Contribute to the promotion, support and recognition of the best interventions (good practices) in the application of current technologies for the maximum inclusion of people with disabilities in the cultural heritage
- Disseminate, promote and support inclusive actions of cultural heritage.
- Encouraging artists to create with inclusion in mind
- Facilitate training in methodologies and technical applications for culture professionals
- Promote inclusive inclusives policies in EU countries



# INTERNATIONAL COMPETITION

## CURABILITY



### Main characteristics to assess

- Creative and sustainable solutions over time (sustainability)
- That they can be extrapolated to other places (transferable)
- That they are innovative (innovation and exemplary)

### Categories

- Award for heritage conservation
- Prize for the best good practice Inclusive culture

\*\*\* Nominations must comply with the specific requirements of the category to which they are submitted, which must be stated in the data sheet

\*\*\* Submission of nominations implies acceptance of all conditions, as well as compliance with the jury's verdict

\*\*\* Suggestion: a prize for each category in each country of the project partner entity

# INTERNATIONAL COMPETITION

## CURABILITY



### **Evaluators**

- Number: 5 - 9 members from the countries of the convening entities
- Representativeness: Professionals of recognized prestige who have an active career in heritage conservation and innovation through ICTs. The president will be elected from among the jury and his vote will be weighted
- The members of the jury will meet one month after the deadline for the call, having been able to examine the works presented for the award and having assessed them individually and having sent said assessment (form) to the coordinator of the Curability project.
- Prizes will be awarded by simple majority. In the event of a tie, another round of evaluations will take place.
- Any of the prizes may be declared void
- The verdict of the jury will be irrevocable and will be made public once the deliberations are finished and said verdict issued

# INTERNATIONAL COMPETITION

## CURABILITY



### **BASES ANNOUNCEMENT**

- Periodicity: Annual
- Call date: January (each year)
- prize delivery: December (each Year)
- Place. European Parliament
- Prizes. Commemorative object / Diploma / Plaque.

### **SCOPE**

- Countries of the members of the Curability project
- Expandable to other countries of the European Union
- State level (each entity will adapt to the territorial model of the country and make the corresponding selections)

### **CONVENERS**

- The partner entities of the Curability project
- Collaborations of public or private entities, in the field of entity influence

# INTERNATIONAL COMPETITION

## CURABILITY



### DOCUMENTATION TO PRESENT

- *Identificative data of the project and the promoter (if not the same)*
  - *Physical person. Personal Identity documentation.*
  - *Legal person. Fiscal identification / Incorporation date / Statutes / Certificate of agreement presentation.*
- *Completion of the corresponding form with all the required data required (category, location of the action being presented, brief description, justification of the action in important terms, start and deadline dates, prize dissemination campaign design...)*
- *Photos and/or video of the intervention considering the initial state, and the state after the intervention (duly identified and publication permission)*
- *A short report on the intervention may be added for a better assessment by the jury*

*\*\*\* Submissions that are late or missing data will not be accepted*

*\*\*\* The presentation will be delivered in digital format*

## CURABILITY



### **DISSEMINATION**

- *The prize winners will undertake to mention the prize awarded to the intervention in all places, networks, web, written or digital model*
- *The awardees will undertake to maintain the award-winning performance; otherwise (abandonment, loss of exemplary circumstances of Good practices), the award may be withdrawn.*
